### **Bike Case Loan Agreement**

#### Bike Case Loan Description:

#### Terms of agreement:

1. Borrower must be a current member of Capital City Cyclists (CCC).
2. E-mail Club Coordinator Jack Tomassetti [jack@cccyclists.org](mailto:jack@cccyclists.org) to see if the dates you want are available. When more than one person requests the same date, the reservation will go to the person who gets their deposit to us first. NO reservation is confirmed until the required deposit is received.
3. A deposit of \$200 (cash or check made payable to CCC) is required. The deposit will be held until the case is returned.
4. There is no rental fee, however CCC requests that the Borrower return the case in a timely manner to allow other club members the use of the case.
5. The Borrower is responsible for pick-up and return of the bike case.
6. The Borrower is responsible for loss or damage to the case. Check your airline's loss/damage policy. For loss/damage claim reports, the value of the bike case should be stated as \$300.
7. The Borrower will not be expected to pay for incidental damage such as minor scrapes or dents incurred through ordinary use. However, the Borrower is responsible for damages that render the case otherwise unusable or if it is lost or stolen.
8. CCC is not responsible for any damage to bicycles or other contents carried in the case while in use by the Borrower.
9. Borrower must include case accessory items (straps and locking brackets) at time of case return.
